The deadline to appeal Youth Olympic Winter Games Team nominations is 1:00 pm (noon) MST on December 18, 2023. Appeals must be submitted in writing to Ski Jumping Canada's High Performance Committee Chair Julie Beaulieu, jbeaulieu@nordiqcanada.ca

#### Eligibility

The Youth Olympic Games quota spots are 1 male and 1 female.

Canada has 4 Male, and 2 Female athletes eligible based on year of birth and with an active FIS license.

2 Male athletes have met eligibility for nomination based on section 3 of the Ski Jumping Canada Internal Nomination Procedures For the Gangwon 2024 Winter Youth Olympics.

2 Female and 2 Male athletes did not met eligibility for nomination based on section 3.4 of Ski Jumping Canada Internal Nomination Procedures For the Gangwon 2024 Winter Youth Olympics.

#### **Qualification Period**

Places will be allocated based on FIS-level competition results achieved in the qualifying period between July 1<sup>st</sup>, 2022, and December 17, 2023.

- Feb 2, 2023 2023 FIS Nordic World Junior Ski Championships, Whistler CAN
- Oct 11, 2023 US Cup and Youth Olympic Games Qualifiers, Lake Placid USA
- Dec 15, 2023 FIS Cup Notodden, NOR
- Dec 15, 2023 FIS Cup Notodden, NOR

Ranking was based on the best individual results from the included competitions in the qualification period. Athletes who did not start in the event will be ranked below athletes with a result from the event.
